Please read carefully before signing, this is an indemnification of the <u>Hamilton Gun Club</u> and waiver of certain legal rights.

In consideration for my being a member, guest or my participation in any of the activities at the Hamilton Gun Club, Inc. (hereinafter referred to as "HGC"), I agree to the following Waiver, Release and Hold harmless Agreement. I acknowledge my being present near discharging fire arms of various typs and calibers has certain inherent risks, hazards, and dangers. These risks, hazards and dangers can be managed, but never eliminated, on an active and public gun range facility, and in my understanding includes, in part without limitation, the following:

- 1.) The risk of handling firearms and being near others, who have firearms in their possession;
- 2.) The risk of ear and eye damages; Eye and ear protection is always required. Shooting without them is at my own risk.
- 3.) The risk of injury from ammunition, clay targets, shot pellets, bullets, bullet fragments, bounce backs and/ricochets.
- 4.) Physical presence in rugged country, including encounters with wildlife, animals and insects.
- 5.) Varying weather conditions, loss of footing from ground obstacles, ice or snow, or low hanging roof clearances.
- 6.) I understand I have the responsibility to exercise reasonable caution and safe gun handling practices at all times, and to obey all posted rules of the "HGC".

In consideration of being a member, or guest of the "HGC" and/or my competing in, participation or simply observing or attending any event conducted on the "HGC" property, and in recognition of the best efforts of all individuals involved to maintain reasonably safe conditions and rules, I agree to assume any and all personal risk(s) involved. Furthermore, I affirm and understand that I for myself, my family, heirs, successors, executors and subrogees, hereby knowingly and intentionally waive, release, indemnify and hold harmless the "HGC", all of its Officers, Directors, instructors, employees, agents, members, including match officials, volunteers, or any event sponsors involved in organizing or conducting events of any type or nature from any and all personal injury or property damage(s) I might incur. Additionally, I waive all present and future right(s) to any and all claims, actions, causes of action(s), legal suits and expenses (including reasonable attorneys fees) against the "HGC" and the aforementioned individuals. Such waiver by me includes NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, any damages, losses, injury, paralysis or death to me as a result of my attending any event, or my use of any HGC services or equipment while present on HGC properties. Additionally, I understand I'm fully responsible for any injury to myself or others and any property damages I may have caused while at the HGC facility.

Undersigned expressly agrees this instrument is intended to be as broad and inclusive as permitted by law, and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforce ability of the remaining provisions shall not be impaired thereby. No

remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statue or otherwise. The election of any one or more remedy hereunder by the HGC, or any of its Officers or Directors shall not constitute any waiver as such and to their rights to pursue other available remedies in accordance with Montana State Law.

Should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States or of any State, or under any theory of law or equity, THE UNDERSIGNED WILL INDEMNIFY, HOLD HARMLESS AND DEFEND THE "HGC" FROM ANY AND ALL COSTS, expenses of liability including, but not limited to , the cost of any settlement or judgment made or rendered against the "HGC", whether individually or jointly with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all "HGC" range rules and procedures, Furthermore, the Undersigned acknowledges that he/she has the option of pursuing firearm activities at other locations than the "HGC" and that he/she has had ample opportunity to read and consider this document and to seek the advice of an attorney, if desired.

In exchange for and as a condition of being allowed to participate in the SCTP, Athletes and Athlete's parent/legal guardian (if Athlete is a minor child) agree as follows:

- 1. Athlete acknowledges that the SCTP is a team-based program that provides TEAM competitions in trap, skeet, sporting clays, Olympic Bunker Trap, and International Skeet which involve the use of firearms. Athlete further acknowledges that the SCTP emphasizes and REQUIRES the SAFE HANDLING and USE of firearms at ALL VENUES or LOCATIONS where firearms are present. Failure to adhere to this requirement may be grounds for removal from the SCTP
- Athlete requests to participate knowing and understanding that there are risks and dangers associated with the use of firearms, including serious bodily injury, death and property damage.
 Athlete agrees to assume all risks, inherent or otherwise, that may occur due to, arise out of or be in connection with Athlete's own participation, including without limitation the risk of serious bodily injury, death and property damage. Athlete further agrees to assume all risks, inherent or otherwise, that may occur due to, arise out of or be in connection with the participation of others in the SCTP, including without limitation other competitors; instructors / coaches; staff or volunteers of SSSF, SCTP Sponsors, or the Governing Bodies; and audience members.

NOTE: Please be advised that it is not possible to list all of the activities and related risks that Athlete may encounter by participating in the SCTP. There may be risks that are not known to Athlete, or to other athletes of the SCTP, including staff or volunteers of SSSF, SCTP Sponsors or the Governing Bodies, and may not be foreseen or reasonably foreseeable by anyone at this time or at the time of the activities in which Athlete participates. I understand the Scholastic Clay Target Program's first and foremost priority is safety. I will enforce the SCTP's safety standards with my child at all times. I will encourage my child and other team members to have fun. I will behave as a positive role model, respect the goals of the SCTP, and reinforce the character values of good sportsmanship, teamwork, and self-discipline. I agree to stay off the shooting field. Any problems or criticisms will be presented in a positive way to the coaches or a designated assistant. I will refrain from criticizing other shooters, coaches, using abusive language, or consuming alcohol or drugs before or during all SCTP activities that I attend. I understand that unsportsmanlike behavior on my part may result in me being asked to leave the area. Such actions on my part could also result in my child being disqualified or even removed from the SCTP.

By signing this form, I affirm that I have read and understand the behavioral standards for parents as stated above and the behavioral standards for my child as stated below, and that I agree to abide by the stipulations therein.

FEDERAL LAW

YOUTH HANDGUN SAFETY ACT NOTICE

- (1) The misuse of handguns is a leading contributor to juvenile violence and fatalities.
- (2) Safely storing and securing firearms away from children will help prevent the unlawful possession of handguns by juveniles, stop accidents, and save lives.
- (3) Federal law prohibits, except in certain limited circumstances, anyone under 18 years of age from knowingly possessing a handgun, or any person from selling, delivering, or otherwise transferring a handgun to a person under 18.
- (4) A knowing violation of the prohibition against selling, delivering, or otherwise transferring a handgun to a person under the age of 18 is, under certain circumstances, punishable by up to 10 years in prison.

The Gun Control Act of 1968, 18 U.S.C. Chapter 44, provides in pertinent part as follows:

18 U.S.C. 922(x)

- (x) (1) It shall be unlawful for a person to sell, deliver, or otherwise transfer to a person who the transferor knows or has reasonable cause to believe is a juvenile—
 - (A) a handgun; or
- (B) ammunition that is suitable for use only in a handgun.
- (2) It shall be unlawful for any person who is a juvenile to knowingly possess--
 - (A) a handgun; or
- (B) ammunition that is suitable for use only in a handgun.
 - (3) This subsection does not apply to--
- (A) a temporary transfer of a handgun or ammunition to a juvenile or to the possession or use of a handgun or ammunition by a juvenile if the handgun and ammunition are possessed and used by the juvenile-
 - (i) in the course of employment, in the course of ranching or farming related to activities at the residence of the juvenile (or on property used for ranching or farming at which the juvenile, with the permission of the property owner or lessee, is performing activities related to the operation of the farm or ranch), target practice, hunting, or a course of instruction in the safe and lawful use of a handgun;
 - (ii) with the prior written consent of the juvenile's parent or guardian who is not prohibited by Federal, State, or local law from possessing a firearm, except--
 - (I) during transportation by the juvenile of an unloaded handgun in a locked container directly from the place of transfer to a place at which an activity described in

- clause (i) is to take place and transportation by the juvenile of that handgun, unloaded and in a locked container directly from the place at which such an activity took place to the transferor; or
- (II) with respect to ranching or farming activities as described in clause (i), a juvenile may possess and use a handgun or ammunition with the prior written approval of the juvenile's parent or legal guardian and at the direction of an adult who is not prohibited by Federal, State or local law from possessing a firearm;
- (iii) the juvenile has the prior written consent in the juvenile's possession at all times when a handgun is in the possession of the juvenile; and
- (iv) in accordance with State and local law;
- (B) a juvenile who is a member of the Armed Forces of the United States or the National Guard who possesses or is armed with a handgun in the line of duty;
- (C) a transfer by inheritance of title (but not possession) of a handgun or ammunition to a juvenile; or
- (D) the possession of a handgun or ammunition by a juvenile taken in defense of the juvenile or other persons against an intruder into the residence of the juvenile or a residence in which the juvenile is an invited guest.
- (4) A handgun or ammunition, the possession of which is transferred to a juvenile in circumstances in which the transferor is not in violation of this subsection shall not be subject to permanent confiscation by the Government if its possession by the juvenile subsequently becomes unlawful because of the conduct of the juvenile, but shall be returned to the lawful owner when such handgun or ammunition is no longer required by the Government for the purposes of investigation or prosecution.

- (5) For purposes of this subsection, the term "juvenile" means a person who is less than 18 years of age.
- (6) (A) In a prosecution of a violation of this subsection, the court shall require the presence of a juvenile defendant's parent or legal guardian at all proceedings.
- (B) The court may use the contempt power to enforce subparagraph (A).
- (C) The court may excuse attendance of a parent or legal guardian of a juvenile defendant at a proceeding in a prosecution of a violation of this subsection for good cause shown.

18 U.S.C. 924(a)(6)

- (6) (A) (i) A juvenile who violates section 922(x) shall be fined under this title, imprisoned not more than 1 year, or both, except that a juvenile described in clause (ii) shall be sentenced to probation on appropriate conditions and shall not be incarcerated unless the juvenile fails to comply with a condition of probation.
 - (ii) A juvenile is described in this clause if--
 - (I) the offense of which the juvenile is charged is possession of a handgun or ammunition in violation of section 922(x)(2);and
 - (II) the juvenile has not been convicted in any court of an offense (including an offense under section 922(x) or a similar State law, but not including any other offense consisting of conduct that if engaged in by an adult would not constitute an offense) or adjudicated as a juvenile delinquent for conduct that if engaged in by an adult would constitute an offense.
 - (B) A person other than a juvenile who knowingly violates section 922(x)--
 - (i) shall be fined under this title, imprisoned not more than 1 year, or both;

and

(ii) if the person sold, delivered, or otherwise transferred a handgun or ammunition to a juvenile knowing or having reasonable cause to know that the juvenile intended to carry or otherwise possess or discharge or otherwise use the handgun or ammunition in the commission of a crime of violence, shall be fined under this title, imprisoned not more than 10 years, or both.
